A Proposal to Analyze One of Adrienne Kennedy's Plays Written During the Civil Rights

Movement to Raise Awareness of Discrimination.

Introduction

Throughout history in the United States, discrimination has constantly been an issue. As a result, from 1954 to 1968, the Civil Rights Movement took place (Kolin 1). The Civil Rights

Movement focused on fighting against racial discrimination in order to close the gaps between races.

As one of the first African American playwrights, Adrienne Kennedy took the risk to write out her story in a play that was later released out to the public and became the center of attention. Being African American was not the only issue that bothered many during this time period. Women in general were also considered of less importance compared to men. They were typically inferior to men as the African Americans were to whites. For Kennedy, identity played a huge role in determining who she was and how others treated her.

As a biracial woman, she was not able to fit in, which triggered her to write a play called the *Funny House of a Negro*. Having to fight through several factors of discrimination, the playwright was still able to portray her troubles from her life through the main character of the play, Sarah, "The Negro". She had difficulty trying to accept her biracial identity living in the United States during the early 1960s (Kolin 1). She was unable to endure the emotional pain caused by the fact that her father is African American. The audience is able to see the hardships that people experienced during the Civil Rights Movement, but most importantly, what she had to deal with. She was able to clearly portray what it was like to be both female and biracial in the United States at the time. As she stated, "I know no places. That is, I cannot believe in places. To believe in places is to know hope and to

know the emotion of hope is to know beauty. It links us across a horizon and connects us to the world" (Hartigan 6).

To avoid this complication from continuing, a change or an attempt for alteration is necessary. This serves as a proposal to raise awareness of the cultural difficulties from biracial alienation and discrimination experienced during the Civil Rights Movement. This proposal includes written statements of what types of curated artifacts will come through in my exhibit, including my statement of purpose, objective, plan of action, and an annotated bibliography of secondary sources.

Statement of Purpose

Portrayed through Sarah, Adrienne Kennedy expressed the hardships she faced, one of which was her biracial identity (Hooks 1). She was not expected of much, but still had standards to satisfy, such as maintaining natural hair, which symbolizes the prejudice. Inequality in general has gradually become something natural in that people do not realize the way they distinguish, categorize, and discriminate others from themselves daily. That goes for both race and gender. This still seems to be the case nowadays due to some unresolved issues that have stayed unknown and unstated. There are many minor incidents being concealed, which I believe have acted as obstacles in resolving the complications.

The importance of this proposal for my exhibit is through my curated artifacts, which will address the stories of the playwright to allow the audience to come to a realization that whether or not someone is different in color, each individual is human and that they are not significantly different. Each person in this world has unique upbringings, which makes everyone unique, but not different. Biracial alienation and discrimination experienced during the Civil Rights Movement was a topic that was not taken lightly, which is the reason for the necessity of discussion. Many famous activists have shared their thoughts for their own specific reasons, but with the same result in mind. As simple as the idea may sound, not everyone acts upon it. Therefore, it is reasonable to say that it is possible to someday reshape the way we approach this issue in order to create a more collective and collaborative society.

Objective

Biracial alienation, the act of separating those with a mixed racial identity, is an ongoing issue that is to be discussed further. Although sympathy may somewhat be beneficial in terms of alleviating the unresolved case, my initial intention is to educate and inform others on the differences that may reshape our lives. I want the audience to be able to take away from this exhibit the idea that diversity rather tends to be more beneficial for us as a whole, just like Kennedy was able to do with the help of her play. Considering the limitations, I am aware that I cannot completely eliminate biracial discrimination, but I want to fill in the gaps that contain potential improvements that can be made for the betterment of our society. My hope is that there will be some changes whether it would be someone's opinion or stereotypes that people make.

Ever since the Civil Rights Movement, it is inaccurate to say that there were no improvements made, but alienation and discrimination still exists today. The stereotypes that people hold today, such as African American women wearing their hair in a certain way as did Sarah, may start to slowly fade away or at least change, which will eventually take on the challenge of settling the unresolved conflicts. As stated in the introduction, my intentions are to raise awareness of the cultural difficulties from biracial alienation and discrimination experienced during the Civil Rights Movement.

Plan of Action

My plan is to consult various types of resources, such as criticism, books, journalism, and archival materials. Each type of resource is unique in that it provides distinctive points, which assists my objective by providing facts, opinions, and diverse perspectives. For instance, criticism, consisting of scholarly analysis, provides specific or various view points and perspectives, whereas a book, consisting of a critical study or a literary work, would describe and give full explanations of social phenomena and historical events. In addition, journalism, consisting of newspaper articles, magazines, websites, and etc., shares a more objective stance, while an archival material would provide original details that are almost like a primary source since it usually is a textual, visual, or audible resource. Some tend to be more opinion-based, biased, or informal than others, which allows me to analyze and consider a variety of information. This is valuable because it helps me be more effective in satisfying

my objective of this exhibit. In order for my exhibit to be effective in raising awareness, it has to stand out, which is determined by the level impact it has on the audience. Two sources that I thought were comparatively adequate and used most were two of the scholarly/ academic journals: "Personal Perspectives on Adrienne Kennedy" and "A Fragile But Ferocious African-American Playwright". They both provided numerous perspectives of the playwright's characteristics, which ultimately supported my arguments in order to satisfy my objective of raising awareness.

On the other hand, I have I have rejected resources such as ethnography, oral history, comparative analysis, and popular culture for one reason. These types of resources are just not suitable, or at least did not work well with what I wanted to accomplish. It was mostly due to the reason that they are irrelevant or unnecessary in terms of my objective.

This scholarly/academic journal talks about the characteristics of Adrienne Kennedy as a playwright, but also as a person. It mentions how she seems fragile and weak, but turns out to be bold and ferocious because of what she does.
